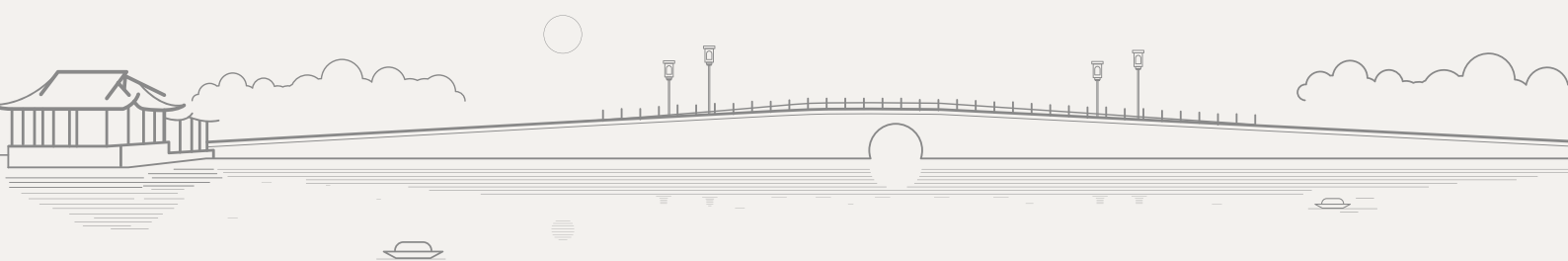

## 主要统计指标解释

**利用外资** 指我市政府部门,企业和其他经济组织通过对外借款,吸收外商直接投资以及用其他方式筹措的境外现汇、设备、技术等。

**外商直接投资** 是指外国企业和经济组织或个人(包括华侨、港澳台胞以及我国在境外注册的企业)按我国有关政策、法规,用现汇、实物、技术等在我市境内开办外商独资企业、与我市境内的企业或经济组织共同举办中外合资经营企业、合作经营企业或者合作开发资源的投资(包括外商投资收益的再投资)以及经政府有关部门批准的项目投资总额内,企业从境外借入的资金。

**进出口总额** 海关进出口总额指实际进出我国国境的货物总金额。包括对外贸易实际进出口货物,来料加工装配进出口货物,国家间、联合国及国际组织无偿援助物资和赠送品,华侨、港澳台同胞和外籍华人捐赠品,租赁期满归承租人所有的租赁货物,进料加工进出口货物,边境地方贸易及边境地区小额贸易进出口货物(边民互市贸易除外),中外合资经营企业、中外合作经营企业、外商独资经营企业进出口货物和公用物品,到、离岸价格在规定限额以上的进出口货样和广告品(无商业价值、无使用价值和免费提供出口的除外),从保税仓库提取在中国境内销售的进口货物,以及其他进出口货物。进出口总额以观察一个国家在对外贸易方面的总规模。我国规定出口货物按离岸价格统计,进口货物按到岸价格统计。

**境外旅游者人数** 指来我市参观、访问、旅行、探亲、访友、休养、考察、参加会议和从事经济、科技、文化、教育、体育、宗教等活动的外国人、华侨、港澳和台湾同胞的人数。不包括外国在我市的常驻机构,如使领馆、通讯社、企业办事处的工作人员;来我市常住的外国专家、留学生以及在岸逗留不过夜人员。

**境外旅游(外汇)收入** 指入境旅游的外国人、华侨、港澳台同胞在杭州旅游过程中发生的一切旅游支出,对我市来说就是境外旅游(外汇)收入。

## Explanatory Notes on Main Statistical Indicators

**Utilization of Foreign Capital** refers to foreign spot exchange, equipment and technology financed by foreign loans, foreign direct investment and other forms undertaken by Hangzhou government, enterprises and other economic units.

**Foreign Direct Investment** refers to the investments inside China by foreign enterprises and economic organizations or individuals ( including overseas Chinese, compatriots from Hong Kong, Macao and Taiwan, and Chinese enterprises registered abroad ) , following the relevant policies and laws of China, to establish wholly foreign owned enterprises, Sino foreign joint ventures and cooperative enterprises, or to explore resources jointly with enterprises or economic organizations in Hangzhou with spot exchange, material objects and technology. It also includes the re – investment of the foreign entrepreneurs with the profits gained from the investment and funds that enterprises borrow from abroad in the total investment of projects approved by the relevant department of the government.

**Total Imports and Exports** refer to the value of commodities imported into and exported from the boundary of China. It includes the actual imports and exports through foreign trades, imported and exported goods processed and assembled with supplied materials, supplies and gifts as aid given gratis between countries and by the United Nations and other international organizations, and contributions donated by overseas Chinese, compatriots in Hong Kong, Macao and Chinese foreign citizenship, leasing commodities belong to tenants at the end of leasing period, the imported and exported commodities processed with imported materials, commodities trading in border areas ( excluding mutual exchange goods ) , the imported and exported commodities and articles for public use of the Sino – foreign joint ventures, cooperative enterprises and wholly foreign owned enterprises. It also includes imported or exported samples and advertising goods whose CIF or FOB value are beyond the permitted ceiling ( excluding goods without trading or use value and exported free ) , imported goods sold in China from bonded warehouses and other imported or exported goods. This indicator is used to observe the total size of external trade in a country. In accordance with the stipulation of Chinese government, imports are calculated at CIF, while exports are calculated at FOB.

**Number of International Tourists** refers to foreigners, overseas Chinese and compatriots from Hong Kong, Macao and Taiwan, who come to Hangzhou for sightseeing, visits, tours, family reunions, vacations, study tours, conferences and other activities of business, scientific and technological, cultural, educational and religious natures. It does not include employees of permanent offices of foreign countries in our city such as embassies, consulates, news agencies and offices of foreign companies, or long – term foreign experts or students residing in Hangzhou, or persons in transition without spending a night in Hangzhou.

**Foreign Exchange Earnings from Overseas Tourism** refer to the total expenditures of foreigners, overseas Chinese, Chinese compatriots from Hong Kong, Macao and Taiwan during their stay in Hangzhou, which are, for Hangzhou, foreign exchange earnings from overseas tourism.
