

## 主要统计指标解释

**社会消费品零售总额** 指各种经济类型的批发零售贸易业、住宿餐饮业对城乡居民和社会集团的消费品零售额总和。这个指标反映通过各种商品流通渠道向居民和社会集团供应的生活消费品来满足他们生活需要,是研究人民生活、社会消费品购买力、货币流通等问题的重要指标。社会消费品零售额包括:(1)售给城乡居民作为生活用的商品和修建房屋用的建筑材料;(2)售给机关、团体、学校、部队、企业、事业单位的职工食堂各种食品、燃料;(3)售给部队干部、战士生活用的粮食、副食品、衣着品、日用品、燃料;(4)售给来华的外国人、华侨、港澳台同胞的消费品;(5)售给社会集团的办公用品、纸张、帐册、文印用品、计算工具、书刊杂志和奖品;公共用品和纺织品、针织品;学校用的教学用具;文体用品;非专用的劳动保护用品,如工作服、套袖、围裙、手套、毛巾、肥皂等;日用百货和杂品,包括职工食堂用的餐具、炊具、设备和清洁卫生工具等;家具、设备、日用电器、电讯设备、电影器材和照相器材等;取暖用的设备和燃料、防暑、降温的饮料;非生产经营用的交通工具,如小轿车、面包车、工具车、卡车和油料;零星修理的各种零配件、材料、工具、建筑材料等;举办各种招待会、茶话会、宴会用的烟酒茶和各种食品及馈赠的礼品;从公费医疗经费中开支的中、西药品、中药材和医疗器材以及其他非生产性设备和用品。

**限额以上批发零售业** 指批发业年主营业务收入在 2000 万元及以上,零售业年主营业务收入在 500 万元及以上的各种经济类型商贸企业。

**商品销售总额** 指对本企业(单位)以外的单位和个人出售(包括对国(境)外直接出口)的商品金额。这个指标反映批发零售贸易业在国内市场上销售商品以及出口商品的总量。商品销售总额包括:(1)售给城乡居民和社会集团消费用的商品;(2)售给工业、农业、建筑业、运输邮电业、批发零售贸易业、餐饮业、服务业等作为生产、经营使用的商品;(3)售给批发零售贸易业作为转卖或加工后转卖的商品;(4)对国(境)外直接出口的商品,不包括:出售本企业(单位)自用的废旧包装用品,未通过买卖行为付出的商品,经本单位介绍,由买卖双方直接结算,本单位只收取手续费的业务,购货退出的商品以及商品损耗和损失等。

## Explanatory Notes on Main Statistical Indicators

**Total Retail Sales of Consumer Goods** referring to the sum of retail sales of consumer goods sold by wholesale and retail, catering and lodging to urban and rural residents and social groups. This indicator is used to show the supply of consumer goods through various channels to households and institutions, and is very important for the study on people's livelihood, on the purchasing power of consumer goods and on the circulation of money. The retail sales of consumer goods include: (1) commodities sold to urban and rural residents for their daily use and building materials sold to them for the construction or repair of houses; (2) food and fuels sold to canteens of institutions, enterprises, schools and military units; (3) grains and non-staple food, clothing, daily articles and fuels sold to military personnel; (4) consumer goods sold to foreigners, overseas Chinese, and Chinese compatriots from Taiwan, Hong Kong and Macao during their stay in the mainland of China; (5) commodities sold to social groups. Included under this heading are: office appliances, paper, account books, printing articles, calculators, newspapers, magazines and prizes; public articles, textiles and knitgoods; realias for schools; cultural and sports articles; working articles for unspecial use i.e. working clothes, raglan sleeves, gloves, towels and soaps; commodities and miscellaneous goods for daily use i.e. dishwares, cookers and cleaning articles for canteens of institutions, enterprises, schools; furnishings, appliances, communications facilities, film and photograph equipments and materials; heating facilities, fuels and beverages; vehicles (exclude for business use) such as cars, microbuses, trucks and oils; parts, fittings, instruments and building materials, tobaccoes, alcohols, teas, foods for all kinds of reception meetings and banquets and prizes for presenting; Chinese and Western medicines, herbs and medical facilities expenditure by medical insurance fund and other non-production goods and equipments.

**Wholesale And Retail Trade Above Designated Size** wholesale trade, with year main business revenue over 20 million yuan of different status of registration; retail sale trade, with year main business revenue over 5 million yuan of different status of registration.

**Total Sales of Commodities** refer to selling of commodities by the establishments to other establishments and individuals (including direct export). This indicator is used to show the total value of sales of commodities at domestic markets and export. The total sales include: (1) commodities sold to urban and rural residents and social groups for their consumption; (2) commodities sold to establishments in industry, agriculture, construction, transportation, post and telecommunications, wholesale and retail trades, catering trade and public utility for their production and operation; (3) commodities sold to wholesale and retail establishment for re-selling, with or without further processing; and (4) commodities for direct export to other countries. Excluded are selling of waste packaging materials used by the establishments (units) themselves, commodities transferred without buying or selling procedures, commission income from brokerage in transactions whose settlement is directly handled by buyers and sellers, rejected commodities in the purchase, loss in commodities, etc.
